The requested funds will provide improved restrooms, concessions, press box, and support facilities for youth recreation programs and Major League Soccer Spring Training. Local youth participating in soccer, football, or lacrosse programs will have access to a state of the art facility. Local businesses will benefit from the project as the Complex will provide support facilities for Major League Soccer Spring Training.

The complex currently consists of 4 multipurpose fields and accessory buildings that were separately constructed over the past 30 years. As they were constructed over time, they do not offer a suitable design for effective facility use. The complex is heavily used by several area sports organizations including the Countryside Jr. Cougar Football and Cheerleading Program, Clearwater Chargers (soccer) and Clearwater Lacrosse. These organizations represent over 2,000 youth ranging from 4 to 18 years of age. All of these organizations have disadvantaged youth participants that receive scholarships to promote participation by all, regardless of income. It is also important to note that over 50% of the participation is derived from non-Clearwater residents.

In addition to area sports organization use, the complex hosts many tournaments, and will be the future home of the Chicago Fire?s (Major League Soccer) spring training beginning in 2016. It is estimated that this spring training will generate \$5 million annually in economic impact.

The City is a premier destination in the United States for many large scale events and athletic tournaments and has the supporting infrastructure for success. Presently, the sports tourism industry managed by the City of Clearwater generates over \$200 million in economic impact annually.

City of Clearwater has earmarked \$700,000 as a cash match. The City of Safety Harbor has provided \$350,000 towards the project. Private donations for the project total \$150,000.
