AMU seeks \$1.5 million from the state to support of the construction of a \$12 million, 30,000 square foot academic building and cultural center that will house the University?s new nursing program. The building will include a large lab with state-of-the-art equipment, three nursing classrooms, and six offices for nursing faculty and staff. The ratio of private funds raised to public funds is 8:1.

AMU?s Department of Nursing was licensed by the state's Board of Nursing in 2015. AMU has secured ten active clinical agreements for nursing student clinical rotations, including an agreement with the Healthcare Network of Southwest Florida which operates a clinic with the FSU College of Medicine at their Immokalee, Florida location. This clinic (Florida State Extension) is within close proximity to AMU?s campus. AMU nursing students will do clinical rotations at the Florida State Extension and work with FSU College of Medicine students during their residency. These AMU nursing students will be trained to address the needs of the rural poor in Immokalee and AMU is the closest accredited nursing program to these neighborhoods. These collaborations complement the existing network of relationships and foundation of trust that AMU has with social service providers in Immokalee, Florida through the University?s Mother Teresa Project where hundreds of students regularly volunteer at 6 area agencies.
