All of the requested funds will be used for project specific programming such as: Mobile Art Projects and SAAFE (Social Awareness: Arts for Empowerment) which assists ArtReach Orlando to continue its growth and attainment of its mission of fostering creativity and hope, develop self-esteem, and offer children a platform to reflect, re-vision, and rejoice. We are a 501 (c) (3) non-profit arts outreach program that works with children in under-served communities exploring the nexus between art and social justice.

Approximately 50% will go towards operational costs like salaries and capital costs (keeping our mobile classroom on the road) the rest will be used to expand our SAAFE anti-bullying programming to more schools. We currently run one SAAFE project campaign each semester and four mobile art truck stops a month.

ArtReach Orlando is primarily funded by a private donor who will match any funds provided by the state.
