The \$800,000 will provide a 1:1 match of the required funding for activities of the Teen Trendsetters initiative, including training for High School Reading Mentors, reading materials, in-home books for home library, and the salaries of Teacher-Advisors to coordinate the program. High school students receive training and meet with elementary students behind in reading skills for one-on-one mentoring sessions one to two times a week. The program requires parents to participate by signing a contract agreeing to listen to their child read, which is made possible by take-home books to build a home library. In Florida, 147 Teen Trendsetter programs operate in 294 schools in 18 counties, including an expansion of 79 new schools in 2014. That means 1,330 Teen Trendsetters mentor 1,106 elementary students in Florida.

High school students involved in Teen Trendsetters have a 96% graduation rate, compared with 73% nationally, and elementary school students who enter the program behind at least a year in reading gain the equivalent of a year in reading ability from this program.
