The 2025 Downtown Miami Master Plan calls on community partners to leverage the beauty of Miami's iconic tropical waterfront, create great community spaces, and promote transit and regional connectivity. As a project specified within the Master Plan, Baywalk offers these desired outcomes.

Miami DDA and its partners are accelerating efforts to complete Downtown Miami?s Baywalk by engaging the community to envision how this 3-mile disconnected and underutilized waterfront trail can become a premiere recreational corridor for walking, running and bicycling. This project seeks to develop a comprehensive design approach for Miami?s Baywalk and rethink how this 3-mile disconnected and underutilized pedestrian corridor can become a world class waterfront experience. The objective is to create a vision for Baywalk through a public engagement process which results in inspiring design concepts and a strategy for phased improvements with the support of a core working group who will guide and nurture this project to completion. As it exists today, Baywalk is fragmented, difficult to navigate and lacks consistent design elements.

With a strong design focus at its core, this effort shall incorporate art as a common thread in its entirety. The project will also be expected to address the planning, environmental, organizational, and financial contexts as part of the overall proposal. The objective is for Baywalk to be a destination that is identifiable and accessible to users Downtown. Whether for recreational or mobility purposes, Baywalk needs to be a welcoming space with identity that provides a unique waterfront experience to visitors and locals.

This project includes the following objectives: (1) maximize public engagement by advancing a community-endorsed design concept; (2) transform this hidden

asset into an active open space, offering a much-needed community resource; (3) encourage active transportation by connecting Miami Dade County?s greater bicycle and pedestrian trail system, including the Underline, the Riverwalk, the Cultural Trail, and linking transit; and (4) advance the identity of Downtown Miami as a healthy community.
