The purpose of the Beach Resiliency Project is to make the beach more resilient by enhancing the dune system and improving storm water drainage. In addition, the project will improve visitors? experience at the beach by updating restrooms, adding more showers, adding recreational amenities, improving dune access, expanding the dunes that protect the beach and, creating a dune promenade, facilitate parking, and safety improvements. Although the project will improve the beach experience, The City will be able to address environmental issues, such as lighting and enhanced dune biodiversity. The City is preparing for a nourishment project in partnership with Broward County, the State of Florida, and the Army Corp. of Engineers. The City will have a cost share for this nourishment project; however, the nourishment project will not fund the improvement the City is looking to undertake that will improve the resilience of the beach above the tide line. This project resulted from a beach park plan that was developed in part with funding from a FDEP?s Coastal Partnership Initiative grant in 2012. The residents and beach community have participated in over half a dozen meeting in the creation and public hearings on this plan. The project will benefit the thousands of visitors to the City?s beach park, city marina, fishing pier, pier restaurant, and the Florida Atlantic University SeaTech facility.
