Behavioral health will be a jobs growth market of 28.5% in the next decade according to the Bureau of Labor Statistics. Jobspin.com estimates that the rate of potential job creation in behavioral health is more than triple expected new worker availability. In order to create jobs, Florida must increase its post graduate workforce development needed for licensure in behavioral health disciplines of all types. The Behavioral Health Workforce Development program at Centerstone has a proven track record of retaining the overwhelming majority of behavioral health participants in Florida jobs. Post graduate workforce development for 100 professionals in behavioral health disciplines will be accomplished at \$5,000 annually per enrollee.
