Bethel AME has been conferred historic landmark status since 1988 by the city of St. Petersburg. Bethel AME is a historic African American church that has served thousands in the St. Petersburg community. The church's 121st anniversary was this past November, and restoration is needed badly. Since 1894 over 30 pastors have contributed to its development.
