The mission and purpose of the College of Undergraduate Studies (CUS) is to promote student success by providing students with a comprehensive learning experience that fosters transition from high school to higher education, personal transformation, social responsibility, spiritual growth and academic success. The CUS provides a transformative academic experience for undergraduate students while preparing college-ready students for an academically rigorous college experience. The CUS will provide students with access to a quality, higher education through the Bridge to Success Program. The CUS will expand programs, staff and infrastructure to focus on increasing fall-to-fall retention rate, currently at 61.40%, via a comprehensive enhancement of student learning experience and transition. In the request for FY 2016-17, we are requesting funding to support the CUS to implement a student success model which addresses four areas: 1) supportive, timely and effective academic advisement; 2) creation of a university-wide mentoring program; 3) implementation of living-learning communities; and 4) expansion of our summer bridge program. The target population groups for this project are the approximately 1,000 incoming and returning freshman and students.
