Florida American Legion Boys State and American Legion Auxiliary Girls State are a unique summertime leadership/government program that does not emphasize classroom lectures and textbook learning. Instead, it focuses on participation and personal experience in a model state, complete with governing bodies and elected public officials. It is designed to mirror the structure and operation of its respective state government. Upon arrival at both Boys State and Girls State, the young men and women are assigned to one of two political parties. Those parties area called the ?Nationalists? and the ?Federalists?. Such a political organization results in involvement at the precinct level, the city and county, judicial circuit, senatorial or legislative district as well as at the state level. Boys State and Girls State allows the participants to form and operate their government without strict control and excessive supervision by adult volunteer staff. Functional activities start with a caucus or other method of nominating candidates for city offices and conclude with the election and inauguration of the Governor of the mythical state organization. Every citizen, 530 rising seniors from all over the state of Florida, becomes an integral part of Boys State, and 300 rising seniors from all over the state of Florida, become an integral part of Girls State, assuming responsibilities and performing duties either as an elected or appointed official, or otherwise fulfilling an assignment entailing the duties of responsible citizenship.
