Funds allocated for the Bradford-Union Technical Center will be used to expand existing programs plus create new programs for competitive job training. The Truck Driver Training program needs to re-pave their driving loop and repair their loading dock (\$25,000) plus purchase a used dump truck and flat-bed trailer for the Commercial Driving ?B? program (\$34,000).

The Welding Program has had a waiting list for three years. This successful program requires additional space (\$40,000) and equipment (\$37,000) to allow entry for waiting students and to provide workforce ready graduates. These people are waiting to be trained for their jobs.

The new medical assistance program needs \$38,000 for an instructor, \$40,000 for classroom and laboratory space plus \$36,000 for new materials, supplies, and equipment. These funds totaling \$250,000 will allow two small counties in my 4 county district to update their ability to meet citizen need and clear our student waiting list.
