The corridor, which runs through the north end of West Palm Beach, runs parallel with the Intracoastal Waterway and is just blocks from marinas, boat builders, and related businesses. In fact, the economic impact of the boating business has increased 112 percent since 1999 to \$1.35 billion, more than twice the impact of the citrus industry. Designated as a mixed-use district, this main thoroughfare is being transformed as several fa?ade and landscaping improvement projects are underway. In addition to the aforementioned efforts, to spur the redevelopment of Broadway, the Community Redevelopment Agency (CRA) has acquired several parcels for private mixed-use development. The request for funding this year is to build upon the achievements of the City?s economic development initiative. In order to insure the success of these redevelopment efforts, the City and the CRA are looking at redesigning the Broadway Corridor. The road planning and redesign of the roadway is to encourage redevelopment and economic development through improved walkability for pedestrians and roadway safety. To achieve this goal, the City seeks funding for road design and planning of lane reductions and on street parking to slow traffic from 40th street to 25th street. The cost for the design and planning is \$450,000. Since Broadway Avenue is a State roadway, the CRA staff has already begun discussions with FDOT regarding the proposed redesign of the road.
