The Cape Canaveral Lighthouse Foundation (CCLF) requests \$800,000 to continue the lighthouse restoration activities by re-constructing four historically significant Lighthouse Keepers? Cottages and operating them as an historical, educational and commemorative site for the public?s use. The re-construction would restore the historical configuration of the buildings surrounding the lighthouse that existed during the period 1868 to 1950. The buildings will be used as (1) an education center, (2) a museum-type archeological center, (3) a replica Head Lighthouse Keeper?s Cottage and (4) public restrooms facility will be built in the configuration of the original storage building.

An environmental assessment, environmental baseline survey, soil exploration and geotechnical engineering, topographic survey, boundary survey and legal description and sketch are all complete. The requirements were necessary to obtain the license to build on the Cape Canaveral Air Force Station. Funds for these requirements were raised from grants written by CCLF. The building license issued by the U.S. Air Force was granted in 2015 to CCLF to begin construction. The Foundation has partnered with Hensel Phelps Company who will manage the construction of the project. Hensel Phelps? services will be donated, therefore, no salaries will be paid. The requested funds will be used entirely for the construction of the four buildings.
