The Central Florida Zoo and Botanical Gardens (CFZBG) currently offers conservation and education programs based on national and state standards serving 189,000 children grades 1 ? 5 from 5 Central Florida Counties. This project enables the CFZBG to serve middle and high schools and colleges/universities from the same counties and beyond.

The US job growth from 2012? 2022 is expected at 11%:

In 20012 the CFZBG obtained an additional 17 acres from Seminole County. This increased the Zoo?s footprint for future growth. The Zoo has determined the best use of the land is to develop an Educational/Conservation Campus for veterinarian center, conservation center, classrooms, labs/research and auditorium.

Total build out is \$19 million (ESTIMATE). \$2 is estimated in site planning and preparation. In our considerable experience site planning and preparation is NOT a philanthropic driver. A request from the State to launch the plan is requested.

The funds are to be used for water, sewer, power and IT lines. No funds will be used for salaries nor operational expenses.
