This project will address roadway and drainage deficiencies on a residential connector street.

Stormwater runoff from the surrounding community discharges into an unnamed ditch which ultimately discharges into the Eastside Canal. The unnamed ditch between N. Maryland Avenue and N. Palm Drive in Plant City has eroded banks that have destabilized the surrounding properties. The City has received complaints from the property owners requesting that the City reestablish the ditch to its original location and stabilize the banks. Plans are in development now and will be completed in late 2016, thereby allowing this project to move forward immediately upon receipt of the requested funding.
