The funds requested will be spent on an economic development project in Bradenton, Florida at the City of Bradenton's Tournament Sports Park, a city-owned facility. The funds will go towards capital improvements to the facility.

The facility hosts over 60,000 people per year. There are over 100 teams that utilize the facility. The teams include youth teams, travel teams, college teams, fantasy camps, foreign teams and nonprofit groups. Improved facilities and fields to attract additional events generating additional revenues.

Many of the individuals who participate in events located at the City of Bradenton's Tournament Sports Park stay at local hotels and eat at local restaurants. As a result, in 2014, the sales taxes generated by these events totaled \$167,551.02 and resort taxes totaled \$18,453.15. All in all, helping Florida reach over 100M tourists a year.
