The Historic Cocoa Village Playhouse serves as a significant contributor to the economy and tourism in the City of Cocoa and the Central Brevard County area. The Historic Cocoa Village Playhouse plays a pivotal role in the Historic Cocoa Village vitality as an attractor of patrons from the regional area. The 2014-2015 season was the most successful to date with ticket sales alone in excess of \$1 million. The Playhouse attracts more than 55,000 patrons each year and drives visitors to the retail and restaurant businesses in the Cocoa Village area. Once completed the parking structure would yield an additional 162 new parking spaces to Cocoa Village. Based on a 150 day peak tourism season and spending numbers by the Space Coast Office of Tourism and Visit Florida the additional parking spaces when taking into account direct and indirect spending in the Village would equate to approximately \$6.7 million in ?visitor activity? annually. The requested funding assistance will be used for fixed capital construction costs of the parking structure. (Attached Supporting Brochure and Addendum)
