The \$200,000 in funding will supplement a match by the City for \$250,000. The \$200,000 in funding will be spent on capital costs associated with the traffic mast arm, including design and construction management. Because of the interconnectedness of the 32 cities in Broward County (population 1.82 million), this traffic mast arm will serve a larger population than merely the City's residents and businesses. It will serve residents who travel the city's roads to and from work, play, school, and recreation.

The City will match this \$200,000 with a \$250,000 match.
