The expansion of the Public Training Facility at the Coral Springs Fire Academy will support the additional classroom space needed by the academy as the increase in student population and classes provided continue to increase year after year. This space will also enable the facility to hold the Fire Academy graduations in the facility, host large seminars, retreats and classroom rentals which can equate to additional revenue along with marketing exposure to the academy. Additionally, the facility will serve as an expansion of the backup Emergency Operations Center and employee shelter in case of emergency.

Funds will be used for construction, furniture and classroom equipment.

The City will match 100% of State funding in the amount of \$2.5 Million to complete the total \$5,000,000 project cost.
