The adaptive reuse of a 15,000 square foot vacant warehouse, now owned by the City of Delray Beach CRA, to an 18,000 square foot arts/business incubator containing a minimum of 24 studios, gallery space, classroom/workshop space, business incubator space, and light manufacturing space for shared resources such as 3-D printers, digital fabrication machines & computer-aided design (CAD) software.

? The estimated construction cost is \$2,800,000 including finishes, fixtures and equipment. The remaining funding will be covered by CRA funds.

? The arts/business incubator will create jobs (25-50 permanent jobs in addition to construction and design jobs) and will promote economic development through the creation of an arts/business incubator.

o Incubator facilities encourage the establishment and growth of small businesses, generating job growth and job clusters that create a synergy that attracts other businesses and promotes entrepreneurship.
