The city of Hialeah fully finances five congregate sites that offer hot lunches, meal screenings, education and training, home delivered meals, recreation, and transportation to meal sites and boxed meals on the weekend. The Local Service Program provides services for the following zip codes 33010 33012 33013 33014 33015 33016 33018. The congregate meal sites are filled to capacity. The elderly residents are continually growing and increasing the demand for the program. The congregate meal sites have added a second shift to serve a vast number of clients. In the 2013 to 2014 fiscal year, the program served 86,568 residents at the congregate site and home delivered to 43,306 residents. In the 2014-2015 fiscal year, the program served 140,843 residents and home delivered meals to 60,844 residents in Hialeah. The City of Hialeah has seen a significant increase in participants both congregate and home delivered meals. The continued success of the program has provided seniors motivation and the opportunity to socialize with others. The benefits go beyond just having meals.
