The project will increase drainage capacity and reduce the number of drainage outfalls. Currently, six drainage outfalls run storm water into the C-17 regional canal. The project aims to decrease the number of drainage outfalls from six to two and improve the water quality of storm water that runs into the regional canal. The water quality component may include the installation of an infiltration trench or some other water quality measure. This project is shovel-ready to begin work within six months.
