The City wants to create a Quiet Zone for residents and businesses to seek relief from unwanted train horn

noise. If established, a Quiet Zone would restrict locomotive horns from being routinely sounded at railroad crossings. Currently, state and railroad laws require that horns be sounded beginning at

a point 1/4 mile in advance of the crossing and continue until the crossing is occupied by the locomotive. Because of the small geographic size of our City and the number of crossing, this means the horns

are almost continuous when a locomotive is traversing our City. Federal rule allows the establishment of a Quiet Zone if municipalities add Supplementary Safety Measures (SSM?s) to crossings to compensate for the absence of train horns. The US Department of Transportation Federal Railroad Administration uses a risk index to evaluate these additional safety feature upgrades added at each intersection.

The U.S. Department of Transportation Regional Manager met with us to view our crossings and evaluate proposed SSM?s. During this process we were contacted by residents of Daytona Beach who were

independently attempting to create a Quiet Zone near Wilder Avenue. We included

this crossing in our proposed Quiet Zone and there was no objection from Daytona Beach City officials. On April 20,2015, the City filed a Notice of Intent to create a Quiet Zone with all required parties. The 60-day review period passed with no objections or comments filed by interested parties. Once funding is identified, the City will proceed with the proposed modifications below. Once these modifications are in place the City will file a Notice of Establishment will all required parties and a Quiet Zone will be established.
