The City of Sunrise requests \$2,000,000 towards the \$7,000,000 cost of a redundant natural gas feed designed to provide a back-up gas line for current customers, to offer sufficient supply for large volume commercial users, and to expand the number of customers the Sunrise Gas System can serve. The City is committed to providing safe and reliable natural gas service to nearly 10,000 homes and businesses in Sunrise, Tamarac, Lauderhill and Weston. Adding another gas supply feed will increase capacity and expand the economic development opportunities in Sunrise and beyond. The City is uniquely positioned as the only city-owned gas utility operating in South Florida and has grown into the 6th largest municipal gas system in the state. Using natural gas for vehicles, water heating, cooking, clothes drying and central home heating can greatly reduce CO2 emissions and can lead to long term environmental sustainability and significant cost savings. This additional natural gas line is necessary to meet service requests from commercial customers such as City Furniture, which has requested additional capacity to develop a fueling station for its vast fleet of delivery trucks, as well as, a potential public fueling station. The new gas line would also bring natural gas availability to a large number of restaurants and other commercial and industrial entities that currently have no access to natural gas.
