Training of our emergency service teams (both air and ground crews) is critical in providing timely and professional response throughout the State of Florida. Missions include searching for missing aircraft, disaster relief missions as a result of hurricane, tornadoes, flooding, etc.

CAP Digital aerial photography capabilities will be improved and used to support the Florida Department of Emergency Management. Our increased capabilities will allow CAP to provide greater support to local and county organizations and governments agencies.

Our Cadet Program funding (young people age 12 to 18) will be utilized to supplement the operational expenses that are currently self-funded by our cadets. Additional funds will be used to support and develop cadet leadership academies, color guard academies, and emergency services academies. Florida Wing CAP has a nationally recognized cadet cyber security teams and this additional funding will assist Florida Wing CAP provide additional support and resources. Aerospace education funding will be focused on providing and improving quality STEM activities and education. This will include planning, developing, coordinating and implement statewide model rocketry and remote control aircraft educational program.
