The purpose of this project is to serve underprivileged and underrepresented girls residing in District8. The target will be middle school and high school females. The project focuses on training girls in STEM (science, technology, engineering, and math) subjects to prepare for college and a career in the respective fields. STEM and leadership training will be provided to girls through a weekly afterschool program, mentoring program, and STEM field trips. There is a high demand for minority women in STEM fields, and this project will help solve that problem.

This request is a sub-part of the entire organization?s projects and events. Funding for this specific project will be disbursed for afterschool program costs, mentoring program costs, salaries, consulting fees, and educational field trips.

There is a great need for a (girls) program such as STEM and college prep in District 8 and other areas. The community supports our efforts through giving, volunteering, and mentoring. We will serve District 8 in a higher capacity and with expanded programs. We anticipate serving 20 girls in middle school and 20 girls in high school who will be matched with a professional mentor, and receive training in STEM fields. Upon completion of the project, we anticipate results at 100% interest in STEM fields, and 100% of girls properly mentored per the mentoring guidelines.
