Replace roof system on Building A (old Student Services Building). Upgrade of chilled water line in utility tunnels from 8" diameter to 12" diameter. Replacement of failed air handling units in Buildings C and J. Replace aging chiller and elevator motors. Renovation and remodeling of this type will protect the taxpayers' large investment in higher education facilities. Further deterioration will be prevented, and the useful life of the buildings involved will be extended. Need has been determined by survey according to the Florida Department of Education standards. Seminole State College serves more than 30,000 students. A full-spectrum of adult education programs, ESOL programs, post-secondary adult vocational programs, certificate programs, A.A. degrees (either terminal or for transfer to a 4-year institution) and limited workforce-oriented baccalaureate programs are provided to serve the needs of our students and employers in Seminole County, the Orlando region, and throughout Florida.
