The funds were in the original House budget, but were not included in the final conference report in the summer of 2015. As with most public structures, regular renovation & remodeling cycles are necessary to maintain the basic serviceability of the facilities. Standard use would include repair/replacement of HVAC systems, repair/replacement of building roof structures, renovation of facilities to meet needs of instructional space or other deferred maintenance.
