Apalachee Center/Gracepoint/Henderson Behavioral Health Community Forensic Treatment Expansion Proposal:

>Apalachee Center in North Florida currently operates 50 Level 1 community residential placement beds for Floridians with serious and persistent mental illnesses who are involved in the criminal justice system. Gracepoint, in Hillsborough County and the Tampa region, currently operates 24 Level 1 community residential placement beds for Floridians with serious and persistent mental illnesses who are involved in the criminal justice system. Henderson Behavioral Health, in Broward County, has a lengthy history of providing excellent residential care for seriously mentally ill individuals, and of positive involvement in the forensic mental health system.

>Forensic hospital services within the state psychiatric hospital system cost a minimum of \$333- daily (11/12 Senate report). Wait times for these beds are currently at or close to maximum statutory capacity. The 3/31/15 report by staff on the Committee on the Judiciary contained in 2015?s Senate Bill 1452 noted the urgent need for expanded capacity, and proposed funding diversion program pilots modeled on the Miami-Dade program (Daily bed cost: \$285.00). Apalachee and Gracepoint?s community residential forensic step-down program, in operation and growing since 2007, was most recently funded at \$240- per bed daily.

>Apalachee Center, Gracepoint and Henderson Behavioral Health, working in partnership, are able to expand their current programs with four more 16 bed units (64 total beds). 16 of these beds will be situated in North Florida (Gadsden County), 16 in Central Florida (Hillsborough County), and 32 in South Florida (Broward

County), in physical plants requiring only minor renovation. These new programs would cost of \$240- per available bed day, a total of approximately 5.58 million dollars annually (contrasted with 7.78 million dollars for those same clients in State care), and provide a statewide solution to the current forensic mental health capacity crisis.

>Implementation of this expansion would result in additional savings to the State of approximately \$2.2 million in the first year of operation for those clients who would otherwise be in State forensic beds, create private sector jobs, and, most importantly, relieve the current forensic bed crisis. Together, the Apalachee and Gracepoint community forensic residential programs have had over a decade of experience and successful treatment with this high risk residential population, during which time the State has saved over six million dollars on the cost of treatment for these clients. The programs utilize evidence based practices including a comprehensive care model, with integrated physical health care available onsite.

>The new expanded programs would be available for direct diversion services from County jails in Broward, Pinellas, and Gadsden and Leon Counties, as well as step-down services from State secure forensic beds, thereby supporting the efforts of the Governor?s recent Executive Order regarding forensically involved mental health clients.

Program Outcomes

Since the program?s initial inception in 2007, the programs at Apalachee and Gracepoint Forensic Residential Programs have admitted 184 residents and successfully discharged 78 residents who have had their competency restored, returned to the court to complete the judicial process or moved to a less restrictive level of care. The Department of Children and Families has recognized these programs for effectively treating and preparing high-risk, hard to place residents for the next level of care in their recovery.
