This much needed transportation enhancement project will provide complete street drainage improvement along SW 25th Street. All funding requested will contribute to the design and construction of approximately 1.5 miles of a transportation enhancement roadway that includes storm water system upgrades; ADA sidewalks; resurfacing of the roadway; bike lanes installation of traffic calming devices, installation of landscaping and irrigation system. This project corridor benefits three (3) local cities and serves as a transportation route for a total population of 267,037. This roadway is impacted by wear and tear from cut through traffic from area state roads, county roads, and neighboring municipalities. Once these Complete Street Drainage Improvements have been completed, the area residential and business property values will increase and contribute to the tax base. This project will enhance the quality of life of residents within this underserved, at-risk community that has been adversely impacted by slum and blight for over 20 years. These Complete Street and Drainage Improvements will improve water quality for Canal C-9 and address road impact hazards (improper lighting, potholes, ADA sidewalk impairments, stormwater, drainage and flooding, etc.). Once this project has been completed, the City of West Park will be able to maintain the entire corridor. Upon completion, this area will be able to better accommodate the 267,037 population that use SW 25th Street. Residents and businesses are in support of the project and are eager to see these improvements fully implemented.
