Benefits for new Hospital Equipment:

- o Hospital will not lose approximately \$40,000 in 2016 and over \$100,000 for 2017 in reimbursements due to the outdated equipment not being compliant with all regulations and requirements.
- o Significantly improve quality of care by providing greater accuracy in diagnosing patients which directly affect better patient health outcomes.
- o Patients in the surrounding area will have the option to use their local hospital rather than having to travel to Tallahassee and or Panama City.
- o Modernizing hospital equipment increases Doctors Memorial Hospital?s ability to attract and obtain qualified specialists who provide radiology services. Doctors Memorial Hospital, Bonifay ?\$414,675 non-recurring general revenue to purchase and replace critical radiology equipment critical to hospital operations and patient safety.

Doctors Memorial Hospital is a 20 bed critical access rural hospital facility with a 10 bed emergency room with telemedicine capabilities, swing-bed program and offers sub-specialty services from specialists from Nemours Children Clinic dedicated to providing quality care to the Bonifay, Florida Community and surrounding area.

Rural hospitals are usually the only source of emergency medical care in rural areas for life-threatening situations and play a crucial role in attracting physicians to rural areas. The Legislature deems the benefits derived from these features to be truly significant as rural counties with hospitals have lower accidental death rates and lower incidence of low birth weight than rural counties without hospitals. In addition, rural hospitals enhance their communities beyond the scope of health care as they are among the largest employers in rural areas and substantially foster economic development and growth. For these reasons, the Legislature finds that rural hospitals are widely viewed as integral to the welfare of rural communities.
