Funds will be spent towards the creation and implementation of a six-month long, Gardens-wide exhibition, Marc Chagall?s Cote d?Azur: The Artist?s Botanical Imagery and Inspiration Found on the French Riviera. The centerpiece of the exhibition will be ?The Lovers, 1937,? an original Chagall masterwork on loan from the Israel Museum, Jerusalem, along with accompanying art and other objects.

Increased tourism generated by Marc Chagall?s Cote d?Azur will require that Selby Gardens improve its ticketing, traffic management, security, and customer service. The development of robust new programming and presentations to engage tourists and schoolchildren will necessitate increases in Education and Horticulture staffing. These improvements will bring jobs and new spending that, in addition to tourism, will have a significant economic impact on the Sunshine State. During the exhibition alone, the estimated economic impact is \$495,000 in state revenues, \$389,000 in Sarasota County revenues, and 295 FTE jobs. Preopening spending will result in an additional estimated \$469,000 in Florida revenues, \$369,000 for Sarasota County, and 268 FTE jobs. Future exhibitions built on the model piloted by this exhibition will result in similar future impacts.

Currently, Selby Gardens welcomes some 150,000 visitors annually. This urban bayfront garden is recognized worldwide for its serene beauty and for its stellar collections and research on orchids, bromeliads, and other plants. This cultural tourism initiative will benefit Selby Gardens, the Sarasota/Manatee SMSA, Southwest Florida, and the State of Florida through increased visitation by cultural tourists. There is clear and compelling documentation that cultural tourists spend considerably more than other types of tourists.

The Gardens has already confirmed \$505,000 in local donor and foundation support for this project including funding for essential capital improvements, and we have more than \$100,000 in additional verbal commitments as well as strong interest expressed by solid funding prospects. We are applying for additional grants including federal funds to underwrite this groundbreaking tourism initiative. We hope to raise at least \$10,000 in federal (NEA grant deadline for the relevant period is February 25) funding and to use some \$25,000 of our annual Florida Division of Cultural Affairs grant towards Chagall (actual amount will be finalized once FY 2016-17 award amount is confirmed). Most of the remaining funding will be raised from local individuals, businesses and foundations. Community enthusiasm for this project has been extremely positive, so we do not anticipate any difficulty in meeting our fundraising goals.

The intended purpose of this exhibition is to double attendance by tourists at Selby Gardens during the exhibition?s six-month run, build national and international visibility, and create a model and the infrastructure needed to support future programs of similar impact and reach. Local, regional, and state-wide interests will benefit from increased tourism and related spending during the FY2017 budget year and beyond. This request is for non-recurring funds, including some start-up costs, for the pilot project.

This exhibition, the first in a series of blockbuster interdisciplinary art and horticulture exhibitions at Selby Gardens, will bring world-class art to Sarasota and display it in an entirely new context that invites viewers to relate great art to nature. The exhibition will encompass the entire Gardens, including a spectacular plant/art display in our Tropical Conservatory, signage featuring quotes from Marc Chagall about nature and flowers, and scenery reminiscent of the charming French village of St. Paul de Vence. Accompanying programs will include French food and drink, special tours, a curator?s lecture, and performances by topranked arts organizations such as Sarasota Opera, Sarasota Orchestra, Perlman Music Program, and others. Selby Gardens will welcome Israel Museum Director James S. Snyder to Sarasota prior to the exhibition premiere.

We request FY 2016-17 funding from the state of Florida for the following (see table below for a more detailed budget):

The Gardens will invest in a national marketing campaign in coordination with VISIT FLORIDA. The six-month long exhibition will be enhanced by an array of multi-sensory programs designed to excite tourist interest, including:

? A keynote lecture and other programs featuring guest curator Carol Ockman, Ph.D., of Williams College. Dr. Ockman, a scholar on French and contemporary art and culture, is the author of several books and has curated exhibitions at the Jewish Museum, New York. She holds Ph.D. and master?s degrees from Yale University and a B.A. from Stanford

? Themed tours and education programs

? French-themed performances by Sarasota Orchestra, Opera, Perlman Music Program and others

? French-Riviera themed food and cooking demonstrations

Audiences served will include a mix of Florida residents, out-of-state, and international visitors. During our most recently completed fiscal year, 45% of those served resided in Sarasota County, 21% were residents elsewhere in Florida, 29% were out-of-state U.S. residents, and 5% were of international origin. We believe that our marketing campaign will increase the percentage of both out-of-state and international visitors during the six-month exhibition.

We estimate that we will serve the following age groups:

School-based youth: 6,500 including approximately 2,600 from Title I schools

Non-school based youth: 8,500

Elders: 35,000

Total Visitors (during 6-month exhibition): 100,000
