Roughly 85% of young children receive their early learning experience from for-profit child care centers which often operate on a thin margin. While larger centers and chains are able to afford curriculum experts dedicated to ensuring sound and rigorous lesson planning and curriculum continuity from age group to age group, centers located in high poverty communities clearly lack the resources to provide this enhancement.

For the last 3 years ELCOC has partnered with Orange County Public Schools (OCPS) to pilot a Curriculum Coach Initiative which connects an OCPS certified teacher with early childhood experience to 4 to 6 child care centers serving children from birth to age 5 who are zoned to Lockhart Elementary. The Curriculum Coach works with each participating center to strengthen teacher capacity to use observational assessment and apply best practices in teacher child interaction to promote learning and build successful transitions into kindergarten. Emphasis is placed on building vocabulary as well as math and science skills. The model is based loosely on the Coaches deployed toOCPS elementary and secondary schools and is highlighted in the OCPS Strategic Philanthropic Plan.

Targeted Response: The ELCOC proposes to expand the Curriculum Coach Initiative into District 48 by connecting a Coach to 4 to 6 child care centers with children ages birth to 5 who are zoned to Lancaster Elementary and a Coach to 4 to 6 child care centers with children ages birth to 5 who are zoned to McCoy Elementary. Currently? of the over 100 early learning programs in District 48 receive child care subsidies and/or VPK to promote school readiness. The two OCPS elementary schools selected have consistently started the school year with 54% of their kindergarten class not ready on the Florida kindergarten readiness assessment.
