Because DOC is not equipped with current technological tools to acquire, consolidate, cleanse and analyze data, they are unable to effectively measure behavior, improve outcomes and make data driven decisions on how to best utilize the resources they are given.

Equipping the Department with critical analytical tools will help the Department and the Legislature better understand and manage two discreet problems:

- 1) the HOW, WHY, WHEN, WHERE and WHO of prison fatalities and how best to mitigate future incidents
- 2) how to best focus the resources available for job training and recidivism programs by using data science to accurately identify people within three discreet groups: those will end up back in prison no matter what services they receive, those who will never return to prison whether they receive services or not, and the last group being prisoners who have the potential to be positively impacted by services and therefore need and deserve the best and most services possible and available
