The Promenade project plan is aimed at maximizing the number of people that can be accommodated downtown, either by living (residential), staying (hotel), or visiting (events). The project plan provides for venues from small festivals to huge races and regattas, along with a continuous waterfront path experience and pier with docking capabilities at the foot of 8th Street. The budget for the project plan is more than \$6.7 million. The activity if expected to generate significant business for Monroe Street businesses and others in the vicinity. Increased business activity will generate additional property value and sales tax collections. Construction impacts will create 84 total new jobs earning \$5 million in income and generate more than \$11 million in gross state product. The incremental activity created by the project plan will create more than 100 permanent on-going new jobs earning \$4 million in income and generate more than \$15 million in annual gross state product. Development of the project plan is expected to increase residential and visitor counts to the area by 20,000 annually. State and local tax on production solely from construction of the project plan will generate \$230,000.
