Today's business environment requires a workforce that is skilled, confident, and knowledgeable in the area of coding. Unfortunately, school programs and schedules in Florida are not exposing students to regular and deep exposure to coding. The proposal is to financially support the implementation of a fully scheduled coding K-5 curriculum at 20 elementary schools in Duval County Public Schools. Students would be exposed to an hour of coding lessons weekly, similar to music and art. Although districts are infusing coding lessons within the elementary setting, they are limited to afterschool or sporadic lessons. This proposal would provide elementary students with consistent exposure and therefore a deeper understanding of coding. A third party study will be conducted to inform the legislature of the benefits to consistent coding exposure and knowledge at the elementary level.
