Easter Seals requests funding to support the relocation and expansion of Easter Seals South Florida's Adult Day Care Center for 90 Adults Living with Alzheimer's and Dementia to be re-located within Hialeah, Florida. Without a relocation, Easter Seals likely will be unable to sustain its Center in Hialeah and adults living with Alzheimer's disease and dementia within this community would be left with no access to adult day care as their cognitive abilities decrease, leaving them to become prematurely either homebound or placed in a nursing home. Due to the location and significant limitations of the space, the Center served only 51 families in 2015 with an average daily census of 37 adults. With the opening of a new adult day care center in Hialeah, we will continue to serve the unique needs of adults living with Alzheimer's disease and dementia and to link participants with additional community support services. The Center will have the capacity to serve 90 families.
