The project will identify and document the impact of Florida?s ocean and coastal economy on the state?s economy. It will provide a report and recommendations so that strategic decisions can be made for job growth and expansion of the state?s economy.

## Benefit of the Project:

This will help the State of Florida focus on ocean and coastal industries and their potential for job growth and expansion of the state?s economy. The economic study will be completed one year from appropriations date. Specific recommendations will assist the State in expanding the statewide economy, focusing on marine-related job clusters across the state and identify areas for job growth in the economic sectors of the oceans and coasts.

## Summary:

Florida is an oceans state that relies on healthy oceans and coasts to support its myriad of coastal industries, ranging from beaches and tourism to ports to recreational fishing and boating and marine research, among others. Over 75% of the state?s population resides in 35 coastal counties. Florida is striving for future jobs and low unemployment in industries that offer opportunities for a stable and growing economy. This project will help facilitate this goal with specific industry recommendations.

In 2010, over \$584 billion in gross regional product was contributed by Florida?s coastal counties to the state?s economy. More than 228,000 jobs in Florida are directly created by activities supported by ocean resources, and this increase to over 440,000 jobs when indirect effects are taken into account. In 2011, about

one of every \$20 work of Florida?s gross domestic project resulted from use of the state?s ocean resources. It is important to maintain and support these ocean and coastal industries.
