The requested funds will be utilized for housing rehabilitation and emergency elderly housing assistance for the city of North Miami's most vulnerable and needy residents. Funding will be made available to elderly owner's single family residential units in need of emergency repairs who meet the program income, occupancy, and guidelines. Funding is being provided by HUD through the CDBG Programs.
