Currently in Pasco County nearly 100 elderly and food insecure seniors are on a waiting list for the Pasco Elderly Nutrition Program. The building of a kitchen would allow the majority, if not all, of the waiting list to evaporate due to the lower cost to produce meals. It is estimated that within a 10 year time span the kitchen would realize approximately 1 million dollars in tax savings to Pasco County. The target population is low income, food insecure seniors.
