Background on Englewood Water District (EWD)

Since 1955 when local members of the unincorporated area known as Englewood, straddling portions of Charlotte and Sarasota Counties, formed a "water committee? the Englewood Water District has operated successfully to provide clean, reliable water resources for its constituents. The District encompasses approximately 44.5 square miles with 4 fresh water and 2 brackish water well fields coupled with lime softening treatment and reverse osmosis facilities. The District also operates a 3.0 MGD Water Reclamation Facility to treat sanitary sewer needs of the areas. As of 2014, 84% of all water customers also receive sewer service.

Summary of the EWD Sewer Expansion Program

In 1988, the District worked throughout the community to develop a master plan to provide sanitary sewer throughout the District. Of the original nine vacuum collection systems, eight are complete. The remainder of the vacuum area, designated as V9 in North Englewood and South Venice, was divided into three sewer expansion projects. These areas are known as V9-A, completed in 2012, V9-B, completed in 2014, and the last area, V9-C, slated for completion in 2016. Additionally, in the future the remaining areas known as alternate, or ?A?, areas will be completed. It is the goal of the District to eventually be 100% on sewer throughout the District.

Summary of the V9C Phase

The V9-C Sewer Project includes the construction of a vacuum sewer collection system. The construction costs will be paid by the District over an approximate 8

month period. The District will make payment to a vender for a quantity of specialized vacuum sewer equipment for installation by the District or a contractor. The construction of the project will be overseen by the District and an engineer of record.

Use of Requested Funds

The District is seeking \$950,000 through grants and legislative appropriations to offset some of the costs in order to maintain assessments to the property owners at an affordable level. This can be accomplished, for example, by offsetting hook-up fees. Many owners within this project are families having low to moderate incomes. Even though Sarasota County has implemented a hardship program to assist the most financially stressed property owners that cannot afford to pay the assessment, without the aid of assistance, affordability still requires some State assistance consistent with the State benefits to this project. A majority of the funds would be kept in the V9 area although the portions of the District within Sarasota County and Charlotte County will benefit.
