Existing Council Chambers will only seat 37 people. During an average meeting, we experience an overflow crowd that must be accommodated in the lobby. Funds are requested to expand the Council Chambers to accommodate approximately 80 people. For the expansion to take place, upgrading of the 1947 Village Hall building to today's fire and building codes is required. The Village Hall is the core of our local government as all of the Village's records and administrative offices are contained in this facility. Hundreds of people visit facility on a weekly basis to conduct business with the Village.
