To meet expanding space needs for its students and programs offered, the campus added 14 portables over the years, all of which are approaching end of recommended life. Planning for a multi-purpose building designed for high-need workforce programs such as machining and other trade certificates to benefit Deltona and the region. This facility would replace the present portables and house classrooms and vocational labs to support the local high school Manufacturing Academy and other trade programs.
