Funds will be spent on scaling the existing, successful Cyber Foundations pilot program taught primarily to veterans and transitioning military in collaboration with one educational institution. The objective is growing the program to serve up to 120 students in collaboration with as many as 5 additional educational institutions around the State. Consultants will deliver all services under project contract (there are no employees). There are over 50,000 unfilled cyber jobs in Florida waiting for qualified, competency-trained cyber employees, a demand projected to grow exponentially. The scaled cyber training program funded by this appropriation points the way to satisfying this demand, establishing Florida as "the cyber state" and creating a model for the rest of the country.
