he Angelus will provide 9 residential beds and 15 adult day training slots for clients on the APD waiting list who meet the profile of existing Angelus clients. In other words, all individuals will have severe physical disabilities with many having ancillary needs such as feeding tube maintenance. The Angelus further proposes that at least two of the residential beds and three of the day training slots be designated for respite purposes. These will allow for temporary relief from the daily grind of caregiving duties so that caregivers can deal with personal and family emergencies or otherwise address important personal and family needs. Respite services provided on a timely basis can prevent crises and unnecessary and unwanted institutional placements that often occur otherwise. Serving these individuals in the community represents a significant taxpayer savings compared to institutional placement and results in a better quality of life for the individuals served. Care at a state institution costs taxpayers roughly \$120,000 per year compared to \$76,588 annually for residential care and \$13,100 for day training at The Angelus. Utilizing community-based services at The Angelus generates potential taxpayer savings of \$2.1 million compared to serving 25 individuals in state-operated institutions.
