Jackson County has four fire & rescue stations that cover 955 square miles. That's a 238 square mile range per station. Two of the stations provide EMT and fire coverage. Two others provide only EMT coverage.

According to an independent report prepared on behalf of the Jackson County Board of Commissioners, there are unprotected areas of the county with significant population. The report recommends the construction of two new fire and rescue facilities.

In addition, Jackson County residents pay higher homeowners' insurance rates because of a high ISO rating (lack of fire station within 5 road miles of a house).

This is a financially constrained county, with no access to funds to achieve this goal.

Use of dollars:

The \$600,000 appropriation will be used for construction of one fire and rescue facility.
