This is Phase 2 of a 3-part project for remodeling Mosely Elementary School in Putnam County so it can be used for badly needed workforce training. Phase 1 was funded last Session and Phase 2 funding is necessary in order to continue conversion of the Mosely Campus for use by technical students. Putnam County is Florida's poorest county according to a study by 24/7 Wall Street. Mosely Elementary School is located in Palatka, deemed Florida's only 'dying' city by the Florida League of Cities. The reason is simple. Families are leaving. These funds along with funds for phase 3 next year are desperately needed.

The Putnam County School District is experiencing alarming drop-out rates. Graduation rates are at an all-time low of 54.9%. The requested phase 2 funding will allow dual-enrolled high school students an opportunity to receive workforce skilled training in the remodeled space. Presently, there is no other space available. Therefore, this request is made with the due gravity of the present situation that desperately needs our help.
