Monies received for this project will be used for the research and development of a proposed fixed-guideway transit opportunity which would connect the South County and Brandon areas of unincorporated Hillsborough County to downtown Tampa. The larger Brandon area will add more than 94,500 people by 2040, and South County will add more than 121,700 by 2040. A study by the Hillsborough County MPO and City-County Planning-Commission showed a potential for 1,200 to 1,300 multi-family units, and 200,000 to 300,000 square feet of office space in Brandon. The pilot program would identify and corroborate the need for Bus Rapid Transit to alleviate congestion and provide more safety for pedestrians, bicyclists, and drivers.
