This program will provide funding a for a high school audio visual/technology grant program similar to a program currently being administered in Georgia. Under this program, schools will apply for a grant that will allow them to acquire an AV/Technology package consisting of high-end HD video camera packages, Extreme Series Encoding Workstations, and associated graphics software that are all used in television and film production. IN addition, the package would provide for 24 months of secure 1 TB server storage, technical support, and upfront training of teachers on how to use the equipment and graphics software. The packages cost \$25,000 per school, so 100 high school will be able to participate in this program. In Georgia, the first 100 schools were brought on board within six months of implementation. By the end of 2015, over 300 Georgia schools will have had the packages installed, and to date, over 7,000 high school students have been trained to use these highly sophisticated programs.

The grant will fund AV/T equipment packages that provide schools with the equipment, server storage capacity, and technical support to provide students with opportunities to earn course credits and industry certifications in the Arts, A/V Technology & Communications primary career clusters. Currently, as many as eight CAPE industry certifications could be obtained by students who are trained to use the equipment and graphic software included in this package.
