Spending Plan for \$900,000 Appropriation

The three Florida Children?s Initiatives are jointly requesting a total of \$900,000 be appropriated to The Ounce of Prevention Fund of Florida through the Florida Department of Children and Families (DCF) budget to stabilize families and promote healthy child development. The Ounce of Prevention Fund will serve as a fiscal agent and liaison/contractor to DCF, awarding sub-grants to approved Florida Children?s Initiative programs, providing administrative oversight and contract compliance monitoring to include coordination and submission of required progress, data and outcome reports, and providing training and technical assistance as needed.

Miami Children?s Initiative (Liberty City) \$285,000

School Readiness: Infant and Child Development Institute - Provides assistance and support to ensure children are entering school ready, teachers in Liberty City?s early learning centers are coached, guided and supported and centers are improving the quality of learning and care. (185,000)

Economic and Housing Stabilization - Provides assistance to families for economic stabilization. Facilitate access to emergency housing relief and basic needs like utilities, food, beds, furniture and clothing. Basic needs items will be available to all children and families within MCI?s Impact Zone. (\$50,000)

Early Learning Scholarships? That provide year round financial support for families with children 0-5 to enroll in a quality early learning center. Of the estimated 5,600 children under 5 years of age in the 10 census tracts that comprise Liberty City only an estimated 19% if children ages 3 and above (1,040) are enrolled in nursery or preschool (2005-09 American Community 5 Year Estimate). (\$50,000)

Parramore Kidz Zone (Orlando) \$285,000

Economic and Housing Stabilization - Provide assistance to families for economic stabilization. Facilitate access to emergency housing relief and basic needs like utilities, food, and clothing. Make basic needs items available to children at sites throughout the neighborhood. (\$85,000)

Youth Employment - Hire a PKZ Youth Employment Coordinator and employ youth at neighborhood partner sites as after school counselors, childcare workers, athletic assistants, office clerks, teaching assistants, and so forth. Youth gain work experience, overcome barriers to employability, build capacity for economic self-sufficiency, and alleviate dire family economic hardship, while at the same time the capacity of small community-based partner organizations is enhanced by youth who serve as staff. (\$200,000)

New Town Success Zone (Jacksonville) \$285,000

Parental Academy - Helping parents and caregivers of NYSZ earn their High School Diploma and enter into vocational programs. This includes the cost of academic supplies and testing materials. (\$100,000)

Mentor Coordinator ? A staff position to coordinate the mentoring program, serve as a liaison to Edward Waters College, and act as case manager and Adult Education teacher. (\$50,000)

Jacksonville Baby University - Equip expectant mothers with the necessary tools to deliver health babies. The class is multiple 8 week sessions where parents have to attend 80% of the classes to be eligible for neighborhood childcare subsidies. (\$150,000)

Economic and Housing Stabilization - Facilitate access to emergency housing relief and basic needs like utilities, food and clothing. Make basic needs items available to children at sites throughout the neighborhood. (\$100,000)

Police Athletic Leagues Youth Director?s Council - A teen leadership program designed to assist PAL students between the ages of 14 and 19 in developing important skills for success in college, the workforce, and life. (\$50,000)

The Ounce of Prevention Fund of Florida \$45,000

The Ounce of Prevention Fund will provide administrative oversight to ensure proper use of funds, and establish and operate a statewide system for monitoring sub-grantees, including tracking and reporting the quantity and quality of services provided by grantees, and the evaluation of program goals/outcomes.
